Following on from my initial correspondence regarding the theatre visit to the Cambridge Arts Theatre, I am writing to advise you of the final trip arrangements and am attaching the Theatre's risk assessment for your perusal.

Theatre venues are no longer requesting to see negative LFTs, or an NHS Covid pass for under 18-year-olds but do ask us to respect the following:

- The cloakroom has limited space for school items, so it is recommended that bags are left at school or on the coach except for first aid kits/medical supplies carried by staff.
- The Theatre encourages and recommend all audience members aged 11+ to continue to wear masks throughout their visit to the Theatre.

We will be leaving college at 12.55pm and ask that the students meet myself and the accompanying staff members: Mr K Burke, Ms L Riches and Mr Agboke at the coach departure area, outside Scott House at 12.50pm. If your child has lunch during break 2, please be aware that the departure time encroaches on their break time. The running time of the play is 90 minutes, without an interval - it is estimated that we will be back at college by 5.30pm the latest.
